Village Description

The Village of Indian Head Park was incorporated on August 4, 1959, and operates under a Trustee-Village form of government. It is a non-home rule community as defined by the Illinois Constitution. The Village of Indian Head Park is a residential community that strives to maintain an atmosphere of natural beauty balanced with community involvement. The current population is 3,809 as of the 2010 census.

Policy-making and legislative authority are vested in the Village Board, which consists of the Village President and six Trustees. This governing body is responsible, among other things, for passing ordinances, adopting the budget, and approving policies. The Village provides many services for its residents and businesses. The purpose of the Village is to provide local government services within its corporate limits.
